

## **Legislative Update**

Here are updates on some of the issues I've been working on this past fall and early winter:

#### **Education Reform**

In late November, the Senate passed an innovative education reform bill establishing a new category of public schools, providing options to improve existing school districts that are underperforming, and putting the Commonwealth in better position to secure federal "Race to the Top" funds to help all public schools in Massachusetts.

I supported this bill, *An Act Relative to Education Reform,* because I believe strongly that every student in Massachusetts deserves a world-class education. Massachusetts has some of the best public schools in the country, but there are schools that continue to struggle for a variety of reasons. We owe it to the children in those schools to provide additional tools that school districts can use to turn themselves around.

Like much legislation that is passed, I don't believe it's a perfect bill. I was pleased, however, with some of the concessions we won to protect workers' right -- and on the whole, I think this bill will improve our state's education system.

### **Supporting our Vets**

Right before Veteran's Day, the Legislature also gave approval to (and Governor Patrick signed into law) legislation to enhance and protect benefits of Massachusetts' veterans and servicemembers.

Included in that bill, An Act to Provide Benefits for Veterans and Servicemembers, are improvements in voting rights for servicemembers originally included in the Freedom to Vote Act, which I filed last January.

I'm pleased that the Veterans Bill included something I've been fighting for: changes to our absentee voting system to make it much easier for men and women serving in the military to vote. Too often, our cumbersome system has prevented many of our soldiers overseas from having their vote counted. This bill will help ensure that those who are protecting our democracy also have the opportunity to participate in it.

#### **Criminal Justice Reform**

The Senate also passed an omnibus crime package in the last week of November, including CORI and sentencing reform.

Reforming our broken Criminal Offender Record Information (CORI) system and sentencing laws will reduce crime and recidivism in our neighborhoods, relieve overcrowded prisons, and lower criminal justice costs. As a matter of public safety and as a matter of responsible budget management practices, this bill is sound policy, and I'm proud to have voted for it.

We often talk, on Beacon Hill, about making government more efficient. This bill we've passed does exactly that.

## **Budget Transparency**

One issue I have been working hard on is that of budget transparency, with a particular focus on the way certain refundable business tax credits are reported.

Right now, there is no transparency around who receives these tax credits, how much they are getting, or how many jobs they have created with the credit.

At a time of extreme budget cuts, this is unacceptable. Tens of millions of dollars go out in the form of refundable tax credits every year - and yet legislators, and the public, have no idea where the money is going or what effect it's having.

Myself and a group of like-minded legislators have been pushing to make this information public, to provide us with the information we need to effectively manage the public's money and a measure of accountability as to the cost effectiveness of tax credits.

During budget deliberations this year, we had many discussions on raising revenue. But it's also important that we make sure we know how that revenue is being spent, particularly when it comes to tax breaks for corporations. These tax breaks might be effective; they might not. The truth is that right now, we simply don't know.

Transparency and accountability are two things I will always be pushing for in our state budgeting process.
